## What data does Oxford Holiday Cottages collect?

Oxford Holiday Cottages collects the following data:

- Personal identification information - name, email address and phone number

## How does Oxford Holiday Cottages collect your data?

You directly provide Oxford Holiday Cottages with the data it collects. Oxford Holiday Cottages collects data and processes data when you:

- Voluntarily complete a customer enquiry form via Oxford Holiday Cottages' website.
- Use or view the Oxford Holiday Cottages website via your browser's cookies.

## How will Oxford Holiday Cottages use your data?

Oxford Holiday Cottages collects your data so that it can:

- Email or phone you with available booking dates for its accommodation

## How does Oxford Holiday Cottages store your data?

- Oxford Holiday Cottages securely stores your data only on its computer system
- Oxford Holiday Cottages will keep your enquiry data for one week. Once this time period has expired, Oxford Holiday Cottages will delete your data from its computer system
- Oxford Holiday Cottages does not pass your data onto any third party

## What are your data protection rights?

Oxford Holiday Cottages would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** - You have the right to request Oxford Holiday Cottages for copies of your personal data. The company may charge you a small fee for this service.

**The right to rectification** - You have the right to request that Oxford Holiday Cottages correct any information you believe is inaccurate. You also have the right to request Oxford Holiday Cottages to complete information you believe is incomplete.

**The right to erasure** — You have the right to request that Oxford Holiday Cottages erase your personal data, under certain conditions.

**The right to restrict processing** - You have the right to request that Oxford Holiday Cottages restrict the processing of your personal data, under certain conditions.

**The right to object to processing** - You have the right to object to Oxford Holiday Cottages processing of your personal data, under certain conditions.

**The right to data portability** - You have the right to request that Oxford Holiday Cottages transfer the data that it has collected to another organisation, or directly to you, under certain conditions.

## What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit Oxford Holiday Cottages website, Oxford Holiday Cottages may collect information from you automatically through cookies or similar technology.

What types of cookies does Oxford Holiday Cottages use?

There are a number of different types of cookies, however, the Oxford Holiday Cottages website uses:

- Functionality — Oxford Holiday Cottages uses these cookies so that it recognises you on its website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used. Oxford Holiday Cottages uses these cookies to collect information about your visit to its website, the content you viewed, the links you followed and information about your browser, device, and your IP address.

## How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of the Oxford Holiday Cottages website features may not function as a result.

## Privacy policies of other websites

The Oxford Holiday Cottages website contains links to other websites. The Oxford Holiday Cottages privacy policy applies only to Oxford Holiday Cottages' website, so if you click on a link to another website, you should read their privacy policy.
